This includes, but is not limited to, all invoices being payable and due in full 30 days from date of delivery. A non-refundable \$45 fee is charged on any and all returned checks. We are also required by the ABC to place any account with an outstanding balance of more than 30 days on a C.O.D. basis, and under ABC rules, we must begin to charge interest of 1.5% per month (18%) annum on any and all balances greater than 42 days overdue, and again each 30 days thereafter, as mandated by State regulations. Terms for newly opened accounts will be due and payable in 15 days for first 90 days. Terms will be extended to 30 days based upon satisfactory payment history. First order will be C.O.D. for all accounts.
